**QUALIFICATIONS**

Ariel J. Quintela was born in Varadero City, Cuba. He, with his family, immigrated to the United States in 1962. He located in Tampa, FL. in 1971.

He started his first business, *A-Investments Realty Corporation*, in 1984. This business began with Mr. Quintela's purchase of an investment property. This building was repaired, and turned into apartments, along with his first office. Providing leadership and business acumen, he continued in the investment of potential income producing properties, but also began to diversify into the repair/maintenance of these properties. He discovered a second part of this business was needed, and added property and building management. With these two core units of his business, he recognized another potential and again expanded to add a third core which is providing site and property management services to other property owners/investors. He also was involved in real estate sales during the 1980's. The company then grew to six employees.

Being sensitive to the market cycles and fluctuations of the 1980's, in 1990, Mr. Quintela divested his assets and created a new company, *A-Investments Development Corporation, d/b/a ArielHomes* with a focus on General Contracting and new home site development.

As President, *Ariel Homes*, his company provided General Contractor services in the development of residential homes and single family homes sites, commercial contractor and remodeling work. During the first year of 1990, the company achieved ten home completions. Using a conservative fiscal approach, the company now targets twenty to thirty home site completions a year, generally on one-half to two acre lots. Due to the successes, the company continues with the core business, but has also expanded into the full development of subdivision sites. The Company currently employs three to five full time people, and has under contract approximately sixty subcontractors and vendors.
