Dear Senior Citizen:

Please find enclosed your application for the Senior Citizen Discount on the Solid Waste Annual Disposal Assessment. This assessment (fee) is included in your property tax bill, which is mailed each year on November 1. To qualify for the Senior Citizen Discount, you must be at least 65 years of age by January 1, 2012. You must own and live in the residential unit you list on this form. Your residence also must be located in the unincorporated area of Hillsborough County (County).

The County's Public Utilities Department, Solid Waste Management Division (SWMD) offers only one (1) discount per household when a homeowner turns 65 years of age and is eligible for a Senior Citizen Discount. **Once you (the homeowner) are approved, the reduced fee is reflected every year, in November, on your Ad Valorem Tax Bill. You do not have to apply again unless you move, sell your home, or in any way change the status of the ownership or occupancy of your home.** The County's SWMD reserves the right to randomly audit the senior citizen discount roll to verify that individuals receiving this discount meet the minimum qualifications.

You must apply for the Senior Citizen Discount on or before August 1, to receive discount on the next annual billing cycle in November.
